TFPD's core objective is epitomized by its existing operations. The community owned lodges in the TFPD stable, open up the natural environment of Southern Africa's Transfrontier Parks and the cultures of the Communities residing in adjacent areas to visiting tourists. Neither the bio-diversity of the area nor the dignity of the people is damaged in this process. Employment is offered to the local community members both at the lodge and in ancillary activities in the tourism value chain. Training is given to the community members in skills that will enable them to make use of entrepreneurial opportunities in eco-tourism and related industries. TFPD's contribution is to provide management, administrative, marketing. sales, training and operational skills and support. In 2010 !Xaus Lodge won the Imvelo Award for Responsible Tourism in the â€~Best Practice â€" Economic Impact' category. This product range allows TFPD to maximize its return from its marketing spend by offering clients a varied wilderness and cultural experience, frequently encouraging return visits to Southern Africa. The TFPD brand is well established with tour operators in Europe and Southern Africa. The excellence of the client service and experience has resulted in regular and repeated business from local and foreign tour operators. The intention is to obtain environmental credentials for all the TFPD lodges but currently !Xaus Lodge is GreenLine certified and FTTSA accredited, and TFPD's Wilderness Hiking and Canoe Trails in Parque Nacional do Limpopo are Green Flag accredited. TFPD have the experience, resources and business vision to effectively develop profitable destinations and activities in the Transfrontier Peace Parks. The destinations gain the benefit from being able to offer a complementary tourist experience to that of TFPD's other products and at the same time reduce its operating costs in areas such as procurement, transport, relief management and overall marketing, financial and operational management.
